Before submitting a funding application you have the option of submitting your idea or concept for feedback from City of Sydney staff.

The ideas form.

This form allows you to pitch your idea and receive feedback on how to develop your project, identify partners and choose the best grants program. This is not an assessment for funding and positive feedback doesn't guarantee funding.

It is not compulsory to complete an ideas form, you may go straight to applying for funding.

Steps for attaining feedback

- submit this form outlining your idea.
- our specialist team members will review your pitch.
- you will receive feedback about how to develop your project, partners you should work with and your best options for funding.

The ideas form should be submitted at least 6 weeks prior to the upcoming Summer (February) or Winter (July) rounds.

Application forms for funding are submitted separately and will be available when funding rounds open in February and July each year.

For-profit organisations are required to match funding with cash and/or value-in-kind when applying for a grant.
